## Tuition and Fee Schedule 2026-2027

This Tuition and Fees Agreement is entered into between Stone Ridge Christian School and the responsible party for the purpose of outlining the financial responsibilities associated with the enrollment of their student(s) for the 2026–2027 academic year.

By accepting this Agreement, the responsible party acknowledges and agrees to the following terms and conditions:

## **Payment Options**

Families may select one of the following payment options:

- Annual Payment: Full payment due by August 1st, eligible for a \$200 discount
- Semi-Annual Payment: Two equal payments due by July 15th & December 15th
- Monthly Payment Plan: 10 or 11 equal payments made through FACTS Tuition Management, Beginning in either July or August and ending in May. Families may select a monthly payment date of either the 1st or the 15th.

Families are able to make tuition payments in person by cash or check, but must submit payment to the Business Office at least seven (7) business days prior to the due date. An active payment plan will still be required for any incidental charges.

All tuition and fee payments are made through the designated payment system, FACTS. Late payments will incur a \$25 late fee for each missed installment.

## **Delinquent Accounts**

Accounts that are past due for more than 90 days will be subject to review and may result in student un-enrollment until payment is received. The school reserves the right to take necessary collection actions on unpaid balances, including third-party collection services, and the family shall be responsible for all collection and legal fees incurred.

## **Early Withdrawal and Program Changes**

An official withdrawal must be made by submitting a written request to the Tuition and Enrollment Manager by email at least two weeks prior to the intended withdrawal date. Early withdrawals will incur a \$500 fee.

Preschool program changes require at least two weeks written notice and will incur a \$50 change fee.

Tuition for mid-year enrollments or withdrawals will be prorated on a monthly basis.

Approved tuition reimbursement will be subject to a 3.5% processing fee, which will be deducted from the total reimbursement amount. This fee covers administrative and processing costs incurred by the school.

## **Tuition Assistance**

Stone Ridge Christian School partners with FACTS Grant & Aid Assessment to evaluate financial aid requests. Applications are reviewed by FACTS and recommendations are submitted to the School Board for final determination.

Families must reapply each year to be considered for continued tuition assistance.

All applications submitted with FACTS Grant & Aid will incur a \$45 application fee.

## **Payment Policy**

Students with an outstanding balance that is more than 60 days past due will not be permitted to begin the re-enrollment process until the account is brought current. During this time, the student will be placed on a waitlist, but an enrollment slot is not guaranteed.

Students will not be permitted to begin the second semester if there is an outstanding balance of more than 60 days unless written payment arrangements have been approved by the Board and the Business Office.

The obligation to pay tuition is both a legal and moral responsibility. Accounts that remain unpaid after reasonable collection efforts may be referred to a collection agency.
